The long-standing policy has prevented ICE agents from arresting immigrants at so-called sensitive locations except under certain circumstances.

- Patients not seeking timely care – fear driven
  - Create welcoming environment
  - Create spaces that are as safe as possible
- 2. Toxic stress on Patients
  - Empower with resources & information



# The Catholic Tradition St. John Paul II:

- Natural right to migrate
- Migrants do not forfeit their dignity

"... the Synod Fathers recalled that "the Church in America must be a vigilant advocate, defending against any unjust restriction the **natural right of individual persons to move freely** within their own nation and from one nation to another. Attention must be called to the rights of migrants and their families and to respect for their **human dignity**, even in **cases of non-legal immigration**". (236)

# What's in a name?

Undocumented immigrants

Refugees

**Asylum Seekers** 

Legal Permanent Residents (LPS) ak.a. Green Card Holders

TPS (Temporary Protected Status)

Significant overlapping concerns, e.g., safety, resources



In general, patients who are immigrants use few health care because of their youth.

They also underutilize health care resources because of

- Fear
- Lack of trust
- Logistical/financial barriers, and
- Desire not to take things they cannot pay for.

# Clinical Challenges

- Create welcoming & Safe Environment – Signage, Printed material, "Front Door Policy"
- Connecting with appropriate resources (legal, KYR training)

# Refresh Front Door Policy

- No access to patient information w/o judicial warrant
- Designate private areas versus public waiting areas
- Environmental cues:

   Include immigration
   status in all non discrimination statements

#### **Know Your Rights**

We recommend that you find and attend a "Know Your Rights" training conducted by a qualified legal services provider. It may help to view online know-your-rights resources if you are unable to find an in-person training session. It is important to know what to do if federal agents come to your door. This information usually includes making a "safety plan" regarding what to do if you are detained and you have dependent children in need of care.

#### **High Priority! Updating Emergency Contacts**

If you are a parent, you want to be sure that your children will be picked up from school by the family members or persons you wish should you be detained.

Important: Be sure that the Emergency Contact information at your child's school is up to date with the name and phone number of the persons you choose. This will be the person the school calls if you do not show up to pick up your children and cannot be reached. You can usually do this online at the webpage of your child's school or school district. It can also usually be done in person at the school's administrative office. You should update this information immediately!

#### Social and Educational Information for Undocumented Youth

Undocumented young people, sometimes called Dreamers, often face considerable stress for a number of reasons. Their own future prospects for things such as higher education can seem limited and they, of course, fear the deportation of loved ones or themselves. A number of advocacy organizations can provide information on navigating potential opportunities and can help individuals to understand that others have faced similar barriers and there can be strategies to address them. Finding local youth advocacy organizations for undocumented youth can be helpful. There are also important national organizations that can provide helpful information and guidance, especially regarding educational opportunities.
