Biographical/Administrative History

Project IRENE began as a result of the initiative of Leadership Conference of Women Religious Region 8, July 1996. The shortened name of this organization is derived from the first letters of the formal title: Illinois Religious Engaging Nonviolent Endeavors. Its mission is to create systemic change through legislation related to decreasing violence against women and children in Illinois. The Leadership Conference of Women Religious (LCWR) represents over forty religious congregations. Motivated by their commitment to justice, Contact Sisters—one woman religious from each congregation—act as community organizers working in collaboration with the Project IRENE director. The director focused on analyzing, educating, advocating, and representing the public face of LCWR in its support of women and children. She spends part of her time at the Illinois State Capitol attending legislative sessions and meeting with elected officials.

Scope and Content

The records of Project IRENE span the years from 1996 to 2012 and are arranged alphabetically within five main series and consist mainly of project/subject files, reports, and some organizational records such as correspondence, photographs, meeting minutes, and newsletters. Subjects include women and welfare, Illinois State Government, temporary Aid for Needy Families, incarceration, work and welfare, fair budget reporting, Illinois legislation, pay day loan reform, immigration, homelessness, and domestic violence.

Series 1: Organization, 1996-2004, n.d., Box 1

Consists of records relating to the operational organization of Project IRENE and include newsletters, contact information, correspondence, open house information, and strategic planning.

Series 2: Meetings, 1996-2005, n.d., Box 2

Contains conference and other meeting material related to the Advisory Council, Congregational Area, Contact Sisters, and the LCWR.
